Late Tariff submission as per Dec 15, 2023 Technical Update:

- New tariffs submitted less than 10 days before the start of competition (**February 29**)
 - \$50.00 per club
- New tariffs submitted less than 5 days before the start of competition (**March 4**)
 - \$100.00 per tariff
- Revised tariffs submitted less than 3 days before the start of competition (**March 6**)
 - \$100.00 per tariff

The judges will review tariff sheets submitted by **March 4** and the Meet Referee will make all attempts to communicate any issues found on tariff sheets to coaches via email by **March 4**. **Tariff sheet revisions must be made and loaded into KSIS by March 4.**

- If the requested tariff sheet revisions are not made and loaded into KSIS by the deadline, penalties will be applied as per the rules. (After that, minor tariff sheet changes can be made as normal).
- After the initial judge's review, concluding on **March 4**, the assigned meet referee will need to be informed by email of each new tariff sheet revision that is posted. Look in KSIS Documents for Meet Referee.

Please bring a back-up copy of music on a USB flash drive (all club music on one flash drive).

KSIS Entry Formatting

When entering pair/groups into KSIS please follow the guidelines and formatting below.

- In the ID field, enter their USAG Pair/Group ID#.

- Next enter the first name followed by the last name of each athlete in the pair/group. Separate athlete names with a comma. This information will be used in the schedule and announcer scripts, so please make sure the names are spelled correctly with FIRST name first and LAST name second.
 - For the order of the names, please enter the top first, followed by middle(s), where applicable and then the base ie: Minnie Mouse, Mickey Mouse.
 - Enter the athletes' USAG member number under National.lic.nr field.
 - Add the birthdate of each gymnast.
 - Please upload a picture of the pair/group. There is a CAMERA icon on the right of the Pair Group Name. Click on it and upload the pair/group picture. There are no requirements for the size of the photo etc. This photo will be shown on the screen with scores.

EVENT SCHEDULE

CHECK-IN REQUIREMENTS

All coaches, judges, medical staff and photographers are required to check in and sign in on the appropriate list at the front desk prior to entering the competition, warm up or athlete areas.

WARM-UP AND COMPETITION SCHEDULE

- A start list and detailed warm-up and competition schedule will be provided at least 1 week prior to competition.
- Exact times to begin stretch, warm-up, and competition will be listed on the schedule.
- There will be no touch warm-ups on the competition floor.

- It is possible for the competition to run one or two routines faster or slower than scheduled. While warming up, keep track of where the competition is and be prepared.
 - Please follow all instructions given by the Floor Manager.

JUDGES AND SCORING

There will be one panel of four judges. Competition groups with more than one exercise will present to the same panel. Two artistry scores will be averaged, and two execution scores will be averaged. The execution averaged score will be doubled and added to the artistry averaged score and the D-score, less CJP & DJ penalties for the final score. For Elite competitors, Bonus skills properly documented and submitted to the judges panel will be added to the final score.

Scores will be displayed to the competitors and public following each exercise. A list of results will also be published to coaches by email at the conclusion of the competition.

AWARDS

For level 2-7, final placement will be based on the score of the combined routine.

For level 8-10 and AG 11-16, final placement will be based on the sum of the final scores for balance and dynamic exercises.

For JE 12-18, JE 13-19 and Senior Elite, final placement will be based on the sum of the final score for balance, dynamic and combined exercises.
